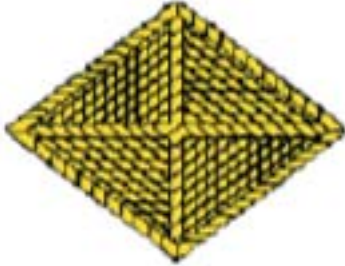

Free Hotel – NCL's Europe Plus program offers 2 free nights in a first class hotel. Hotels are allocated on a "first come, first-served basis and are SUBJECT TO AVAILABILITY. The sooner you make your reservation and pay the deposit (\$400 per person) the better your chances are to be assigned to the RAFINO Hotel, the Tower Thistle Hotel in London

Deviations and Extended Stays – You can stay more than 2 days in London prior to sailing. Each additional day is \$149 per person. You can also stay in London before returning home. Post hotel packages are available. To do that you may have to get an air deviation. NCL Premium Air Service is available. A non-refundable per person fee of \$50 will apply as well as any additional air costs incurred. Premium Air Service can assist you with extended stays, upgrades to 1st and business class, and selection of specific airlines or routings.

Dining – The Norwegian Dream has "Freestyle Cruising" and that includes dining. Breakfast and lunch is open seating. You can eat at the time you choose. Dinner is also open seating but RAFINO passengers will be assigned tables in a restaurant and we will have dinner at a given time. I will make arrangements with the Maitre d' upon boarding the ship. RAFINO DUES

Check the label

before your rank to see if you owe dues:

- One \$ means you owe \$10 for 2002.
- Two \$\$ you owe \$20 for 2001 & 2002.
- Three \$\$\$ you owe \$25 for 2000-2002.

–We have had many inquires and comments concerning dues. I will try to cover the subject.

1. Mail your dues to Dave Mikkelson, the treasurer, at the address shown in the left column of this page.
2. Dues are now \$10 a year and can be paid in advance. The dues year is the calendar year.
3. Finance surviving spouses do not owe dues.
4. Dues are delinquent after 31 March of the dues year.
5. The Treasurer does not send out a bill as a matter of economy. Postage is expensive. Notices will appear on the web site but it is assumed that dues will be paid on time.
6. Notices of delinquency will be sent out since we do not want to lose members needlessly.
7. Current dues status is shown in the individual record of each member in the web roster. The roster is a secure area that requires a member password to access it.
9. The established dues amount does not cover our annual expenses. Fortunately we have some funds from prior years and some members send in donations to help offset this.

The Society of Retired U.S. Army Finance Officers (RAFINO) is recognized by the IRS as a non-profit organization under Section 501(c) (19) of the IRS Code. RAFINO's purposes are set forth in detail in its bylaws. However, simply stated, its major purposes are: (1) to maintain and distribute a roster of members, (2) to issue a periodic newsletter (currently semi-annual), (3) to maintain a current web site on the Internet, and (4) conduct periodic reunions (currently biennial).
